



## Pool Rules and Information

The pool is available to all Hampton Glen Subdivision homeowners and lawful tenants with **current, paid annual dues**. Pool guests who do not live in Hampton Glen **MUST** be accompanied by a Hampton Glen resident. Hampton Glen residents are responsible for conduct and actions of family members and guests.

Each Hampton Glen household will receive one (1) Pool Key-Card that will be activated upon payment of annual dues for the dates and times established for pool season. Hampton Glen pool monitors, board members, or residents may request to validate the key-card, or homeowner and/or guest information, to verify residency.

The pool will be open daily during pool season from 9:00am until 9:30pm. The pool will be closed during inclement weather.

1. Pool use is for residents with current, paid annual dues and their accompanied guests **ONLY**.
2. Children under 14 years of age must be supervised (inside pool area) by adult 18 years or older.
3. Residents are responsible for the actions of their guest(s) and may be asked to leave if not following pool guidelines.
4. All children still in diapers **MUST** wear swim diapers. If an "accident" occurs, please notify a monitor or board member so that the pool can be shocked. Parents will be responsible for cost of shocking the pool.
5. Diapers should be placed in a plastic bag and placed in the dumpster, NOT the pool trashcans or restroom trashcans. Please change diapers at home or in the restrooms. No diaper changes allowed in pool area.
6. Proper swimwear is required. Cut-offs and jeans are prohibited. No towels in pool.
7. Food, drink, or body fluids should be hosed off the deck or deck furniture immediately.
8. **STAY OFF THE ROPE**: It is required equipment to operate the pool. If the rope breaks, the pool must close.
9. Running, pushing people, throwing balls or anything else across the pool, or boisterous conduct is not allowed. Diving is allowed in deep end only. Flips or cartwheels into pool are **NOT** allowed.
10. When playing in pool, be sensitive to persons nearby, especially small children and adults. Games should be limited to the deep end to ensure smaller children are not injured.
11. Profanity, obscene language, and lewd conduct are prohibited.
12. Pets are not allowed in the pool area.
13. Bikes, scooters, skateboards, skates, or motorized vehicles of any kind are not allowed in the pool area.
14. Glass bottles or other breakables are NOT allowed in the pool area (not even inside a cooler). Breakage of glass on the pool deck, even if accidental, may require the pool to be drained and cleaned. The cost of drainage/cleaning will be charged to the HG resident responsible.
15. Tennis balls or leather balls of any kind are not allowed in the pool area.
16. Band-Aids, gum, and water balloons are not allowed in the pool area.
17. Please dispose of trash in the provided containers.
18. Furniture must stay four (4) feet from pool edge (Cobb County safety rule).
19. Umbrellas should be put down upon leaving, or in high wind. All furniture should be put back to its proper location before leaving the pool area.
20. Towels should be used on pool furniture to prevent discoloration caused by suntan lotions and oils.
21. Poolside parties must clean up and remove all trash to dumpsters, **NOT** pool trashcans.
22. **NO SMOKING, VAPING**, or use of other tobacco products inside pool area.
23. HOA Board reserves the right to deny pool privileges to any person(s) for cause.
