 - o tree logs and brush clean up
 - Mentioned to RGS- nothing has been done
 - Nick got an answer on boundary lines

 - Does HOA want to assist with initial clean up?
- Need to clear drainage ditch in common area 3 small trees growing in it and lots of other vegetation. RGS has not done anything yet - Nick will follow up with them
- Considering mulch vs pinestraw
 - stay with pinestraw and tell RGS to be more mindful about blowing it away during leaf cleanup
- Take out remaining ugly bushes along sidewalk to pool. Replace areas with sod or install small plants, etc. like on other side
 - Nick will get price from RGS
- Playground
 - o consider thick rubber mats to go under bottom of 3 slides and under swings
 - Bob will be getting quotes
 - Estimate for covering over playground area- beneficial in summer heat
 - Nick will get estimate
 - other options: tarps, sunshades, etc. \$5K budgeted
- Memorial Area
 - Bob can work on an estimate for improving appearance
 - Nick following up with RGS about more dirt to level the area, plants, rock path, etc.
 - shop around if still no response to Nick
- Clubhouse
 - Events Sign/message board in front by street
 - Nick will send classy options
 - Michele will work with Kimberly Dummett
 - Need to paint clubhouse up under the eaves of the upper windows, other window seals, shutters, etc. Inspect other areas of siding
 - Get quote from Chris Manley for exterior paint
 - Nick will send additional quotes
 - o consider moving trash cans to another area and/or building a fence around them
 - All members pontificate on this

- Revisit Front Entrance Sign in 2020 budget
 - Bring up at annual meeting (3/2 vote not needed)
 - Just maintenance, not changing
